

Furthermore, if you cancel dental coverage, you may not be eligible to re-enrol in the dental plan offered by the College Pension Plan.

Chris Burnley: Your textbook trustee



Chris Burnley is no stranger to doing things by the book. An accountant by profession, Chris has worked both in the public service with the Auditor General of Canada and in private practice with an accounting firm. He's been a faculty member at Vancouver Island

University (VIU) for 25 years, teaching financial accounting and assurance, and has authored two leading financial accounting textbooks that are used by faculty and students at post-secondary institutions across Canada.

Chris was appointed to the College Pension Board of Trustees in September 2023. He was inspired to take on the role of trustee because, as an accountant, he's always been acutely aware of the importance of the plan to himself, his family and current and retired members. "For most members, the plan will be the most significant component of a secure retirement," he says.

Since becoming a trustee, Chris has participated in an incredible amount of learning. In his first six months, he hit the books to learn more about pension governance. Beyond books, Chris appreciates the breadth of knowledge among plan trustees, saying, "There is a lot of experience and wisdom around the board table that I have benefited from."

For Chris, the most interesting area of trusteeship has been understanding the roles and responsibilities of service providers like BCI and BC Pension Corporation (the plan's investment and administrative agents, respectively), and how the oversight process works. He's also focused on learning more about the plan's and BCI's approach to responsible investing. "I want to continue to help develop this for the benefit of both the plan and the planet," he says.

Originally from the East Coast, Chris and his partner, Caroline, have lived in Nanaimo for 30 years and have two grown children. When time permits, they love to explore the great outdoors.

Caroline, also a professor at VIU, is herself a member of the College Pension Plan. This means that after spending a day studying up on the plan and attending board and committee meetings, Chris still has one more member to answer to. "I have some member accountability right at the dinner table!"
